Mitchell County Partnership for Children (MCPC) in combination with USD 273 requests continued funding for our partnerships in USDs 273, 272, 298, 299, 392, St. John's Catholic, Tiny Treasures and USD 273 Early Learning Center and 3 year old KPP preschool that will promote healthy development, strong families, and early learning in North Central Kansas. Our multi-county approach allows us to provide services to more than 200 families in multiple communities at a fraction of what it would cost districts to replicate our programs individually. We propose to continue social/emotional lessons, mental health consultations, PBIS, assessments, data driven coaching to teachers and academic intervention to students not meeting benchmarks. USD 273 seeks continued gap funding for our KPP preschool programs and funding for childcare staff serving at-risk children, as well as funding for childcare scholarships. Our goal is to have all children socially, behaviorally, and academically ready for kindergarten.

Through an evidence-based family mentoring program, the SECSCRP is building supportive relationships and stronger foundations for at-risk families. This project will also prepare at-risk children ages 0-5 for success in kindergarten by strengthening teacher-child interactions, identifying delays earlier, and monitoring growth and development through quality classroom participation stipends, and coaching for early childhood educators. This is accomplished through early educational experiences to prepare children for their next educational setting. Furthermore, a specific focus on social-emotional learning contributes to a strong foundation. Social-emotional learning is supported through developmentally appropriate classroom environments, where teachers engage children in meaningful activities, provide substantial time for child-focused learning, and create structure with predictable schedules, routines, and rules. Lastly, the Coffeyville Model for Early Learning is a community-based approach which is enriched by both public and private partners offering their expertise and funding.

Families and Communities Together, Inc., a non-profit organization, partnering with Marion County Early Childhood Task Force, created the "It Takes a Village..." Early Childhood Collaborative (ITAV) which serves children and families throughout Marion County. This initiative collaborates programs and organizations to create the greatest benefit for Marion County children and families. ITAV offers evidence-based services to at-risk children (birth-age 5) and families by providing coordinated perpetual supports including early childhood screenings, mental health consultations, parent educator training, conscious discipline parenting training, childcare provider professional development, and preschool scholarships. ITAV focuses on early childhood issues while raising public awareness with the consistent goals of ensuring health holistic development, ensuring strong familial support, and ensuring early learning. ITAV is requesting \$188,130 for this project to continue serving approximately 300 individuals.

Our early learning (age 0-3), preschool (age 3-5) and home visiting programs are the elements that drive most of the strategies and touch all three areas of impact as outlined in the Blueprint for Early Childhood: Healthy Development, Strong Families and Early Learning. These strategies are designed to provide access to services for at-risk children and families, to utilize existing and new public/private partnerships and to use evidence-based strategies to ensure quality of service. Developmentally appropriate interventions will be identified based on the assessed needs of the individual child and their family/caregiver(s). Coordination of services and heightened supports during critical transitions across programs and as children enter kindergarten will ensure that children and families are confidently prepared for school success.

FCMHC will provide Project Before Case Management, Parent Education, and Early Childhood 3 of 14 Description of Need Mental Health Behavioral Services / Social and Emotional Classroom Consultation to promote stable nurturing environments through support, education, skills development and linkage to community resources while emphasizing a whole-child/family focus. Alongside collaborative partners, FCMHC will promote high levels of care for at-risk children and families while increasing their protective factors. FCMHC's programs utilize evidence-based practices to strengthen families and promote good mental health practices. FCMHC's programs will target 180 'at-risk' children (0-5), their families, and expectant mothers in Chautauqua, Cowley, Elk, Montgomery, and Wilson counties in FY2023. At least 20 classrooms and 32 professionals will also receive services and support.

Sixty children will attend the USD 489 Early Childhood Connections Preschool Monday through Thursday for 7.5 hours. Teachers will use the Frog-Street Pre-K Curriculum. Family Advocates will provide case management services to 40 families enrolled in the Connections 3 to 5 Preschool. Through regular home visits Family Advocates provide parent and family support services that enhance parent-child relationships and promote the healthy growth and development of families and children. These "wrap around" case management services for families are in addition to the academic services received by children in the classroom.

Our project will provide home visiting and parent education services to 260 atrisk children and their families, birth-kindergarten entry. To implement this project, we are requesting \$452,992 of funding. Geary County, through comprehensive planning, has developed innovative partnerships and strategies that align with the Blueprint for Early Childhood and ECBG Outcomes to build Healthy Development, Strong Families and ensure Early Learning for 260 at-risk children through the implementation of the following programs:

Kansas City, KS Public Schools (KCKPS) is requesting \$1,133,376 to support the district's Successful Programs to Assure Readiness for Kindergarten (SPARK) program. Located in Wyandotte County, SPARK will provide early childhood services for approximately 120 three- and four-year-old children/families residing in KCKPS boundaries. The program proposes to implement the following strategies: 1) assessing students for early identification of needs and providing interventions, 2) utilizing instructional coaching techniques to enhance instructional quality and empower teachers, families, and students to support student social-emotional development and mental health, and 3) providing instruction and teacher training to ensure student success in early literacy and numeracy while supporting teachers in providing a positive learning environment. Using evidence-based practices, SPARK anticipates the outcome of increased academic, social, and emotional readiness for its participants to succeed in kindergarten.

Six programs facilitated by Smart Start Northwest Kansas, under the direction of LiveWell Northwest Kansas requests \$490,220 for an estimated 1,586 high-risk children 0-5 and their families living in 14 northwest Kansas counties spanning over 13,000 square miles. Strategies include risk screening, health education, home visiting, parent education and early literacy and referral. Outcomes include social-emotional development; strong families that provide safe, stable, and nurturing relationships; and early learning to ensure children enter kindergarten ready to learn. FY23 funding meets changing needs of Northwest Kansas residents by expanding its regional outreach to include fourteen counties, the integration of mental health services into its programs, strengthening community referral systems, and co-constructing new partnerships with community members and other organizations.

Early learning facilities, both home and center based, are offering quality, affordable early care and education through RR child care scholarships and professional development. At-risk children entering kindergarten take advantage of RR/USD383 Camp Kindergarten, a summer program to help get ready for school that has shown marked improvements in Common Measures assessments administered. RR provides services to an estimated 220 children from 210 families in Riley County. RR programs work to provide services that build confident parents resulting in strong families that support healthy development and early learning for their children.

The Building Blocks project is a collaborative approach implementing whole child, two-generational, evidence-based programs selected to directly impact the accessibility, availability, and navigation of services for approximately 1,270 geographically isolated at-risk children and their families, aged, birth to kindergarten eligibility (including prenatal supports,) for whom Common Measures will be generated. Selected programs include Triple P Positive Parenting Program, Learn & Play Parent-Child Interaction Groups, Growing Together prenatal to three child/caregiver supports, and Bright Beginnings Early Childhood Center (USD 443) partner programs, all of which align with Cabinet program philosophy, focus on priorities identified in the 2019 Early Childhood Needs Assessment, and address goals specified in the Blueprint for Early Childhood.

Classroom instruction, coaching and mentoring for instructional leaders, childcare financial aid, new infant slots activate the quality and affordability and availability of childcare strategy. Parents as Teachers, Healthy Families, and bilingual Centro Hispano peer support provide direct home or virtual visits with families to activate the parenting education & care coordination strategy. Individualized family therapy coordinated with social emotional consultation in early childhood classrooms and with care coordination activate child & family therapy. We anticipate uniform, consistent screening and referral; healthy social emotional development; high quality learning environments; safe, stable, nurturing relationships.

The anticipated outcome of our project is to improve the emotional/developmental functioning of children at-risk, so they enter kindergarten ready to learn.

Child care services and preschool implementation provide high-quality early learning experiences for at-risk children. Families are strengthened through parent education options. Coaching and consultation services improve teaching practices in community-based child care classrooms serving at-risk children, recognizing the importance of social development, literacy rich learning environments, and family engagement. CASS partners will serve 841 families, 522 infants and toddlers, and 308 preschoolers, helping families thrive and preparing children for success in kindergarten and beyond.

Start Young programming components will be measured alongside common measures in the Blueprint For Early Childhood's three main pillars: Healthy Development; Strong Families; and Early Learning. TFC respectfully requests \$1.6 million to support us in carrying out these goals and creating lasting change for Wyandotte County families.
