The Capital Projects Fund grant is made possible by the US Treasury (Treasury) under the Coronavirus Capital Projects Fund (CPF) program established by section 604 of the Social Security Act (SSA), as added by section 9901 of the American Rescue Plan Act (ARPA) of 2021.

This federal program provides **construction-only** funding to build multi-purpose community facilities designed to jointly and directly enable **ALL** the following federal criteria to be considered for funding:

- The project is designed to address a critical need that resulted from or was made apparent or exacerbated by the COVID-19 public health emergency.
- The project ensures immediate **broadband** access to community members and for a period of no less than 5 years.
- Projects must have explicit design considerations to enable ALL the following activities for a period of no less than 5 years:

- **Work activities** to help community members engage in employment, search for employment, and/or develop the requisite skills and knowledge to become employed (career counseling, workforce training, assistance with job search, etc).
- **Education activities** to acquire knowledge and/or skills, undertaken as part of a person’s participation in school, an academic program, extracurricular program, or life skills development program for students or youths, internship or professional development program, or in another educational environment.
- **Health monitoring services** for an individual’s physical and/or behavioral health.

In addition to the above federal criteria, the Kansas Children’s Cabinet received approval from US Treasury to require the following as a condition of funding for successful applicants:

- **Licensed child care slots** to support quality care and education programming for children B-5 that enable parents and caregivers to participate in employment opportunities.

A total of \$38 million was available across two rounds of awards. Round 1 was approved at a special meeting of the Children’s Cabinet Board on October 19, 2024, awarding 3 grants totaling \$10,254,009. At the February 2024 board meeting, the Kansas Children’s Cabinet approved an additional \$27.7 million for the second round of grants. Seven organizations have been awarded CPF funds to build or improve facilities that offer additional community resources—including child care—for families. CPF grantees have the unique opportunity to dedicate funds to new construction, renovation, or rehabilitation of facilities and other capital improvement for community-driven projects and programs.

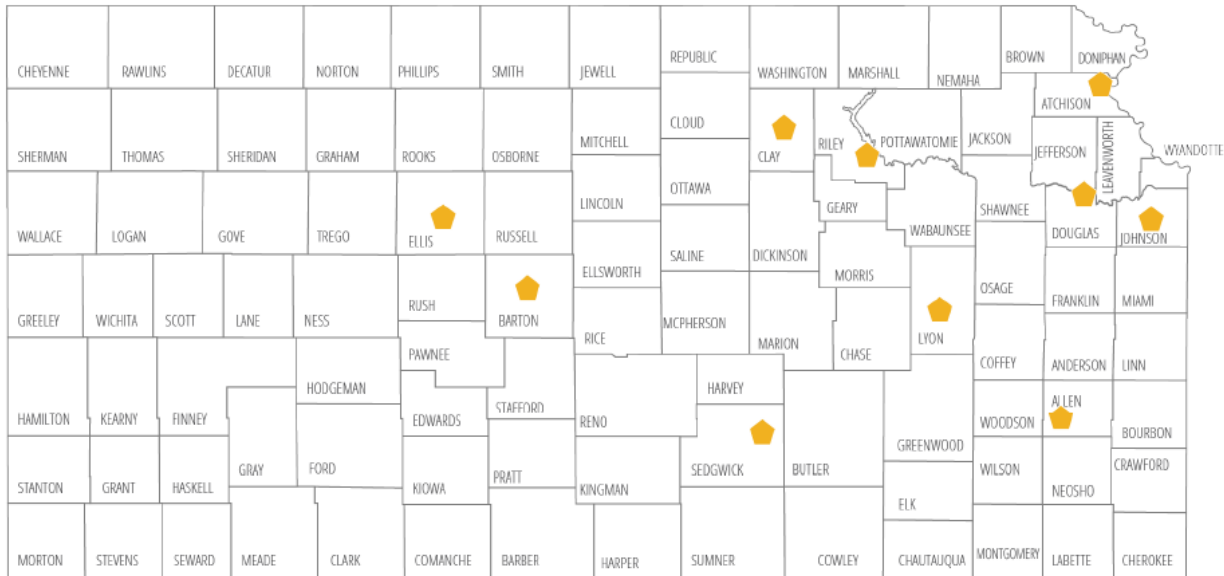

ABCC/Great Bend Economic Development

Overview (Round 2 Grantee)

Establish the Great Bend Innovation Hub, a center designed to ignite a culture of innovation and empowerment while adding 28 new overnight-shift child care slots in the community by May 2025. Through collaborative partnerships in healthcare, workforce, and educational institutions, the hub will offer a comprehensive range of services to elevate the overall quality of life in the community. This includes a community Makerspace, a workforce service hub, a curated schedule of classes, podcast and broadcasting center, commercial kitchen space available for community, and health screenings and preventative care.

Overview (Round 2 Grantee)

Clay Center Multi-Generational Life Center aims to address a spectrum of community challenges by providing a versatile space catered to the needs of different age groups and demographics. The grand opening in April of 2025 will mean space for new child care slots for up to 48 children as well as several common spaces to foster community and connection with local partners. The Center will house a senior space, commercial kitchen available for the community, youth lounge, training rooms/coworking space for workforce and educational programming, and health monitoring services with an emphasis on mental well-being from Pawnee Mental Health. Community Children’s Center, Inc.

Overview

The Douglas County Early Childhood Community Center is a multi-phased project that will bring 69 day, and 69 overnight childcare spots in addition to community supports through the family resource center. The Center will also provide wraparound services through a co-location model including educational programming, health monitoring services, and broadband access. The Lawrence Community is already benefitting from resources provided at this location, with much more to come by fall of 2024. (Application # 4408)

Partnerships with Heartland Works and Manhattan Area Technical College will provide programs and services for job seekers and adult learners in the community, while primary care services will be provided by the Manhattan Free Health Clinic. Child care will be expanded through a business incubator model with 8 independent child care businesses

Overview

The Grove Community Center project will bring 77 licensed child care slots to the Hays area in addition to a variety of community resources. By Fall of 2025, the Grove will be a hub for childcare in a multi-generational setting and access to work and education activities offered throughout the community. The Grove Community Center project exemplifies collaboration and incorporates representatives from higher education, economic development, local governance, and the medical community. This will increase access to child care for lower income families, make online degree programs available to the community at discounted rates, create workforce and job training opportunities, and provide mental health services for the uninsured, under-insured and those who receive Medicaid. Child care services will be available no later than June 2025 (140 slots). Community partners will use the space for a career closet and a workforce training program. Local higher education partners will provide a tutoring program and practicum opportunities, while the Atchison Community Health Clinic will expand medical, dental, and mental health services on site. The Center will partner with HealthCore Clinic for coordinated care, health screenings, and referrals as well as on-site mobile clinic

Overview (Round 2 Grantee)

Cubs Community Care Center will include a new 11,400 sq. ft. facility at the current Athletic and Community complex. The facility will include 24 child care slots (focused on infant and toddler care) and an apprenticeship program for early childhood. Onsite career counselors will assist job seekers with job readiness, application support, and interview preparation. The facility will house a system of care for people birth through adulthood, including primary and mental health care as well as a pharmacy. An expansion of USD 258 Virtual Education Center will provide adult diploma opportunities and satellite college courses. (*Application # 4648*)
