All in For Kansas Kids Strategic Plan Progress Update

Cornelia Stevens introduced Sara Garner, Assistant Director of KU-CPPR, who provided an update on the All in For Kansas Kids Strategic Plan. She encouraged feedback on monitoring methods and discussed the development of quality indicators in areas like family engagement, healthy development, workforce development, program quality and family well-being.

Sara also shared updates on the PDG, including health insurance stipends, Thrive Allen County's navigation support, and the Childcare Zones pilot project. She announced the upcoming Childcare Regional Roundtables, the Future Fellows cohort application coming soon, and Regional Care Conferences in Northwest and Southwest Kansas, urging participants to engage in these initiatives and share opportunities with their communities.

Kansas ASQ Overview

Cornelia Stevens introduced Amanda Petersen and Stacy Clarke from the Kansas State Department of Education, who provided an overview of the Ages and Stages Questionnaires (ASQ) findings in Kansas. Amanda led a discussion on the ASQ in Kansas, highlighting its role in supporting the early childhood system. She noted its use from birth to kindergarten entry and its adoption by the Kansas State Board of Education, during which a timeline visual aid was provided. Efforts to expand ASQ access to community partners and share information about healthy development and screenings were also

discussed. She also introduced the Help Me Grow Kansas initiative, which aims to develop and expand screening events. Below is a snapshot of this initiative. 


Looking at the data - keep in mind:

 The Ages & Stages Questionnaires (ASQ-3 and ASQ:SE-2) are screening tools, not diagnostic tools. They provide a developmental snapshot of a child at a specific point in time. These screenings help detect developmental delays and celebrate milestones.

ASQ Screening and Data Overview

During this section of the meeting, the group discussed the Ages and Stages Questionnaires (ASQ) screening tool for detecting developmental delays in young children. The panel had the chance to look at aggregate data from the statewide ASQ Online System, which included the Kindergarten Readiness Snapshot and accounts administered by Part C programs. Amanda shared that nearly 59,000 ASQ-3 screenings and 50,000 ASQ-SE-2 screenings were completed statewide in 2024, with a significant number for children aged 60-72 months. The data indicated that fine motor skills were a common area of concern across the state.



The group shared strategies to address these identified needs, including providing activity books to families and providers, conducting mini learning experiences, and using classroom tracking forms. Great discussions and examples were shared. Family Friendly Workplaces

Brenda Bandy spoke on behalf of their group.

Update: Since the last meeting, a few members had the opportunity to meet with
the team that developed the North Carolina Family Forward certification program.
They gained valuable insights into the process of establishing the program,
including what the team would have done differently. Moving forward, their
discussion will focus on further exploring the assessment of national practices and
their goal of establishing a meaningful family-friendly designation in Kansas.

Workforce: Exit Interviews

Stephanie Wiggins spoke on behalf of their group.

Update: Shared their plans to analyze data from the workforce survey and collaborate with partners within the next upcoming months.

Workforce: Mental Health Supports

Marie Treichel spoke on behalf of their group.

• Update: Shared their focus on the 8 dimensions of wellness and their plans to research more about using this model into their plan.

Workforce: Targeted Journey Recruitment

Amy Gottschamer spoke on behalf of their group.

 Update: Discussed their plans to focus on building workforce capacity and their plans to research potential partners. Additional information shared that they were able to connect with Taylor Spangler from KSDE and will be meeting with them to learn more about programs offered to high school students. They also had the opportunity to review the Strategic Plan Pillar Goal #2 and how it aligns with their efforts.

The group is interested in hearing from childcare providers with experience in caring for newborns at 6 weeks of age versus 4 to 6 months of age, and how those differences impact care. This will help them educate others and policymakers about the benefits.
