




CHILDREN'S INITIATIVE FUND ORIGINS

The 1999 Kansas Legislature created the Kansas Children's Cabinet as a response to Kansas' participation in the Tobacco Master Settlement Agreement.

EARLY CHILDHOOD BLOCK GRANT OVERVIEW

Early Childhood Block Grant (ECBG) – Community grants to programs supporting children B-5 identified as at-risk and their families.

- Funded by the Children's Initiatives Fund (CIF)
- ECBG Program and Grantees participate in the CIF
 Accountability Process (established by <u>KSA 38-2103</u>: The Kansas children's cabinet shall review, assess and evaluate all uses of the moneys in the children's initiatives fund).



IMPORTANCE OF EVALUATION

KSA 38-2103: "The Kansas children's cabinet shall study and shall initiate studies, assessments and evaluations, by contract or otherwise, through institutions of higher education and other appropriate research entities to identify best practices and to measure and otherwise determine the efficiency and efficacy of practices that are utilized in programs, projects, improvements, services and other purposes for which moneys are allocated or appropriated from the children's initiatives fund."

COMMON MEASURES TOOLS

Common Measure	Description
Ages & Stages Questionnaires®, Third Edition (ASQ-3)	A developmental screening tool for ages 1 month to $6\frac{1}{2}$ years that provides a snapshot of children's development in five areas.
Ages & Stages Questionnaires®: Social-Emotional, Second Edition (ASQ:SE-2)	A life skills screening tool for ages 1 month to 6½ years that provides a snapshot of children's behavior and emotions in seven areas.
Classroom Assessment Scoring System (CLASS)	An assessment of classroom quality for programs serving ages 15 months to 3 years.
Devereux Early Childhood Assessments (DECA)	A behavior rating scale for screening or assessment for ages 4 weeks to 6 years of age.
Individual Growth and Development Indicators (IGDIs)	Measures that monitor growth and development for ages 6 months to 3 ½ years using child-friendly, play-based assessments of communication, movement, social skills, and problem solving.
Keys to Interactive Parenting Scale (KIPS)	An assessment of parenting skills for families with children ages 2 months to 5 years.
myIndividual Growth and Development Indicators (myIGDIs)	Progress monitoring measures designed for children 3 years and up specifically concentrating on early literacy and early numeracy.
Parental Stress Index, 4th Edition Short Form (PSI SF)	A self-report tool for parents of children birth to 12 years old helping providers and families identify different types of stress associated with parenting.
Protective Factors Survey, 2nd Edition (PFS-2)	A pre-post evaluation tool for use with families receiving child maltreatment prevention services.

ECBG PROGRAM GOALS

- Provide direct services to children, and their families, who are at-risk of entering kindergarten socially, emotionally or academically unprepared for success by funding programs that are evidence-based and data-driven.
- Increase access to services in under-served communities.
- Support community collaboration and public-private partnerships.
- Enable alignment with the All In For Kansas Kids Strategic Plan and statewide initiatives to improve access to early childhood services.
- Provide supplemental funding to fill gaps not covered by other funding sources.



ECBG REQUIREMENTS

- A minimum of 50% of children/families served must meet a priority population as outlined in the RFP
- Collaborative Agreement for all partnerships
- 15% match (minimum 5% cash)
- Gap funding to provide supplemental funding to fill gaps not covered by other federal, state, and local funding sources
- Participation in Program Evaluation
 - Understand, collect and report on the required, applicable Common Measures



CBCAP FY2026 TIMELINE REQUEST FOR PROPOSALS (RFP)

- May 14 June 25, 2025: Competitive Grant Application open on Kansas CommonApp portal
- <u>August 1, 2025</u>: Cabinet votes on proposed slate of applications.
 - Any awards approved by the Cabinet are dependent on US Congressional budget action and KCCTF's Federal award notice, which is normally received the month after this meeting.

Grant Year: October 1, 2025 – September 30, 2026
